## MINUTES FROM THE APRIL 24<sup>TH</sup>, 2013 PLSO WESTERN RESERVE CHAPTER MEETING

- 1.0 *Call to Order* –President Mike Hudik called the meeting to order at 7:07.
  - 1.1 *Determination of a Quorum* - A Quorum was determined with those in attendance being: Mike Hudik,

Peter Bell, Bob Dorner, John Francis, Leslie Froelich, Jack Gaydar, Joe Corall, Ann Besch, Mike Besch, Lee Dillworth, and Tim Briggs. Guests from other chapters were Jeff Green and Tom Snezak.

- 1.1 *Agenda Changes* – Tom Snezak was here to help clarify the important agenda item: a discussion about the upcoming vote regarding PLSO 100% membership in NSPS: please see below (item 3.1).
- 2.0 *Reading and Acceptance of Minutes* – Motion to accept the minutes from the February meeting by Bob Dorner, seconded by Peter Bell, motion passed.
- 3.0 *Officer Reports*
  - 3.1 State Delegate – Our chapter's President-Elect John Francis reports from the Executive Committee meeting. Mineral rights' transfer by the existing legal description was a new topic brought up, on which there will be further discussion at future meetings. The most important topic is the need to prepare for the decision regarding our organization's 100% membership in NSPS by the end of the year. The movement to a 100% membership of PLSO in NSPS will require a change to our constitution, so therefore: **Each member will be asked to vote on this matter by the end of the year, probably in November.**

*Because an additional fee will be added to our PLSO membership dues, a ballot will be sent out to the entire membership for their vote on this topic by the end of the year.*

There is a very good argument to be made for Ohio surveyors to belong to the national organization: NSPS. NSPS is the only group that would give **Ohio surveyors NATIONAL REPRESENTATION** in Washington, D.C.

**Last year's defeat of LIGHT-SQUARED, which was not only very helpful but vital to surveyors who use GPS, was accomplished by the national group: NSPS.** In short: Benefits to PLSO members of a unified national organization will include: **STRONGER INFLUENCE** in dealing with federal and state legislators and agencies; **GREATER RECOGNITION** among other professional organizations; and **INCREASED EFFICIENCY** in building on past, present and future initiatives to strengthen the surveying profession.
